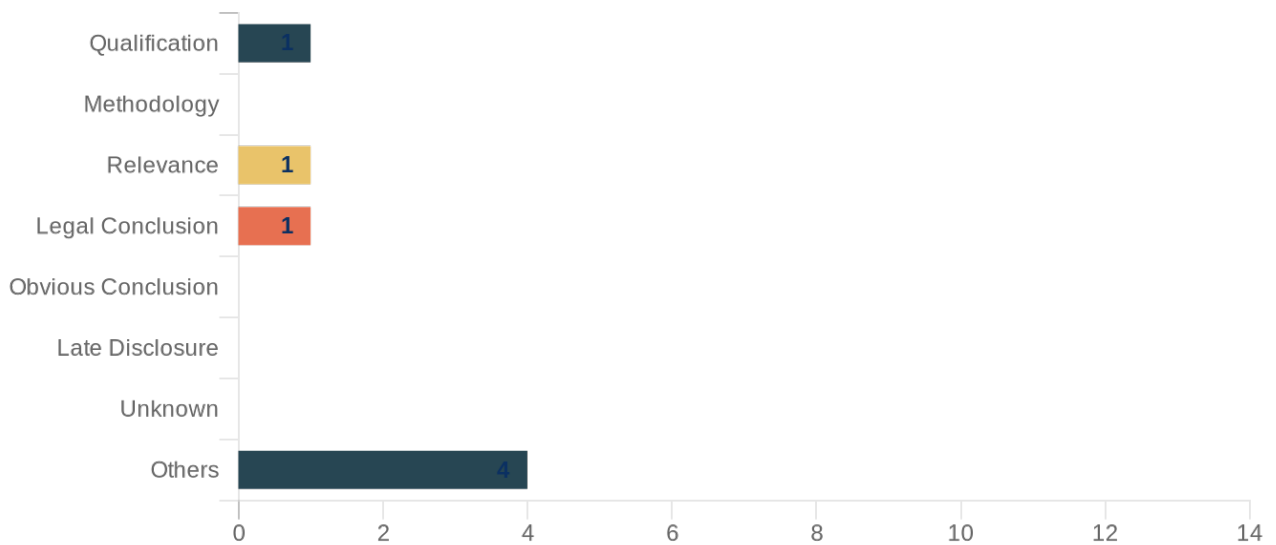

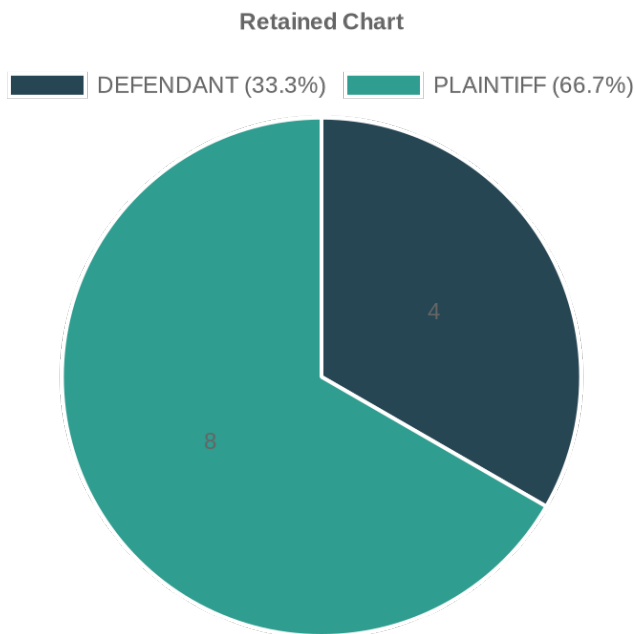

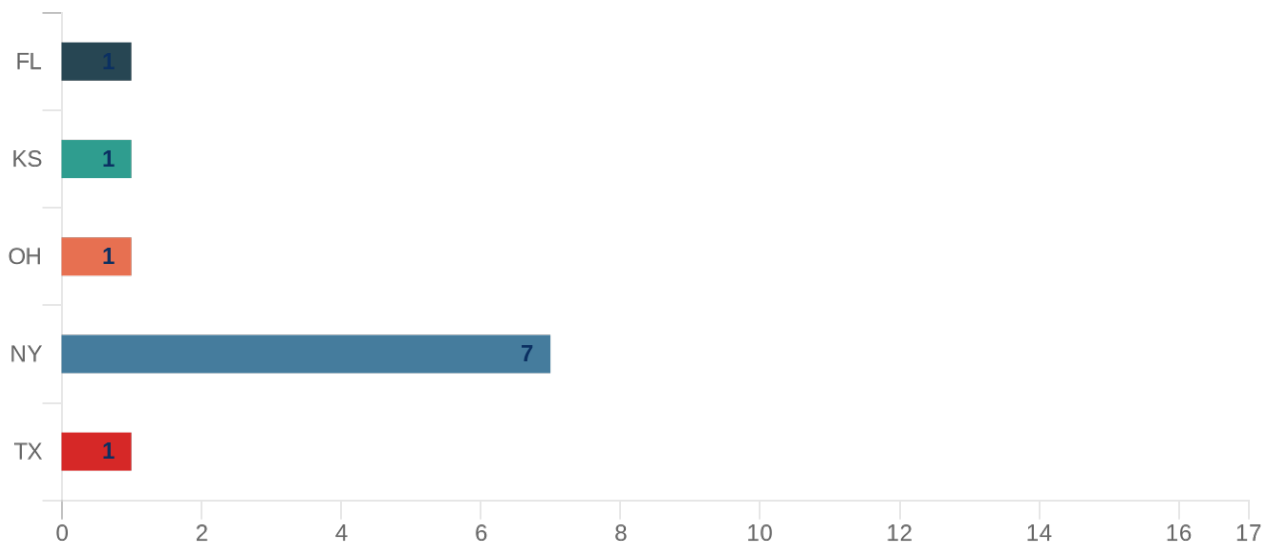


## RETAINED BY (OVERALL)
